Sir/Madam,

With reference to your online application dated 23/04/2014, I am directed to inform you that the Board has considered the undertaking certified by the Management and the Principal of the School on the confirmation page and has decided to grant provisional affiliation to the above said school for **Senior Secondary School Certificate Examination** for a period of three years w.e.f. **01.04.2015 to 31.03.2018** without inspection, in the following subjects:-

- (a) Languages:- Hindi Core, Hindi Elective, English Core, English Elective.
- (b) Elective Subjects: Accountancy, Biology, Business Studies, Chemistry, Computer Science, Economics, Entrepreneurship, Geography, History, Informatics Prac., Mathematics, Multimedia & Web T, Philosophy, Physical Education, Physics, Political Science, Psychology & Sociology.

Since the Upgradation has been granted without inspection as per Circular No.6 issued on 22/01/2013, the school is likely to be inspected at any time in future to confirm its suitability including labs, teaching staff and other requirement required for Senior Secondary Level School.

The above sanction is subject to fulfillment of following conditions:-

1. The school will follow the syllabus on the basis of curriculum prescribed by NCERT/CBSE and text books publishing by NCERT/CBSE for the Middle Classes. The school will follow syllabus and courses as per scheme of studies prescribed by the Board for Secondary/Sr. Secondary School Examination and changes made therein from time to time.
2. The school will implement Continuous and Comprehensive Evaluation (CCE) as per the schemes of the Board upto Classes X vide Circular No. 39/20-09-2009 dated 20.09.2009 in the school and will follow the CCE scheme at Secondary level as per the guidelines of the Board issued from time to time.

- The school will provide well equipped Library with all relevant reference books to the academic level of students and would keep at least 05 books per student subject to a minimum of 1500 books excluding text books.
8. The school will also abide itself by the conditions of affiliation already prescribed by the State Government concerned.
 9. As per Affiliation Bye-laws the optimum strength of a section should not exceed more than 40 students.
 10. School should have at least one adequately equipped computer lab with a minimum of 10 computers and would ensure computer student ratio of 1:20 at least. Proper software along with facility of Broad Band connectivity with the feature of 'Internet always on' from any service provider to be ensured.
 11. The section teacher ratio of 1:15 is to be maintained to teach various subjects and school shall appoint qualified and framed teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board.
 12. The school and its records shall be opened for inspection by an officer/official of the Board or an authorized representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.

The school will apply for further Extension of Provisional Affiliation 'on online' through www.cbseaff.nic.in with the prescribed fee of ₹. 25,000/- and other essential documents before 30th June of the preceding year before the expiry of the date of provisional affiliation otherwise penalty @ ₹ 10,000/- p.m. subject to maximum ₹ 50,000/- will be charged for late execution of application.
 20. The school will open CBSE pattern classes XI w.e.f. 01.04.2015. Accordingly, 1st Batch of class XII of the school will be appeared at the Board's Examination to be held in the year 2017.

22. Special conditions to be complied within three months positively failing which the school is liable for action:-

- a) In few classes the school is having a high enrollment. As per Affiliation Bye-laws of the Board the optimum strength of a section should not exceed more than 40 students. Hence, the school is required to submit a list of enrolment of students class/section wise after rearrange the same as per norms.

Fees should normally be charged under the heads prescribed by the Department of Education of the State/U.T. for schools of different categories. **No capitation fee or voluntary donations** for gaining admission in the school or for any other purpose should be charged / collected in the name of the school and the school should not subject the child or his or her parents or guardians to any screening procedure i.a.w. rule no. 11.1, 2 & 3.
